2. In this connection, I am directed to convey Security Clearance accorded by the Appropriate Authority to M/s.Echelon Edge Private Limited, Unit 726, JMD Megapolis, Sector-48, Gurgaon, Haryana-122001, under the category of "Auxiliary Service Provider".
3. **The validity of this security clearance shall be for a period of five years from the date of issue of security clearance or the period of validity of contract with the airport operator, whichever is earlier**, upon expiry of which a fresh clearance would be required to be taken from this Bureau, for which application has to be submitted through proper channel, at least three months in advance.
4. As per AVSEC Order No.01/2019 dated 19.02.2019, the Company shall submit Security Programme, in prescribed format for the location where it will operate, for approval of BCAS.
5. Only the *bona-fide* employees of M/s Echelon Edge Private Limited shall be allowed to enter and remain in the terminal building or movement area.
6. Prior security clearance would be obtained for any change in management control or ownership pattern of the company/operator(s)/executing the project.
7. This security clearance does not confer any right on the company to acquire business at the airports, if not found otherwise eligible.
8. Director General, BCAS reserves the right to revoke this security clearance at any time without assigning any reasons thereof, in the interest of national/civil aviation security.
